#### FIFA Collaboration with MSU

UT is leading a collaborative project with Michigan State University to prepare the best possible pitches for the 2026 FIFA World Cup—the most ambitious tournament yet, with billions of people around the globe tuning in.

- There will be 16 host stadiums, dozens of base camps, and hundreds of training sites—all with variations in climate, elevation, and stadium conditions.
- Experts in the Herbert College of Agriculture are testing various turfs to create uniform pitches for the sites.
- FIFA's investment will lead to significant advancements in turfgrass science that will reverberate long past 2026.

#### **Digital Learning**

- Attended the ASU+GSV Summit in San Diego in mid-April
- Seeing 30% year-over-year growth in fully online students
- With ASU course exchange, able to remove AA/AS requirements on nine programs and bolster undergraduate enrollment beginning in fall 2024
- Adding eight to 10 undergraduate programs for fall 2025 launch









#### **Council on Competitiveness**

Vanderbilt and UT hosted a summit alongside the Council on Competitiveness on the momentum of Tennessee's innovation economy. Topics included:

- Workforce needs of evolving industries
- Public–private partnerships
- Building the entrepreneurial ecosystem
- Need for infrastructure that attracts and retains businesses

Companies and organizations represented included Nissan, Volkswagen, Bridgestone, Oracle, Google, the Tennessee Valley Authority, Oak Ridge National Laboratory, and the State of Tennessee, among others.

### **UT System Neutrality Policy**

The principal mission of the University of Tennessee is the pursuit and the dissemination of knowledge through teaching, research, and service. To foster this mission, university administrators shall honor the principle of institutional neutrality and refrain from making statements on disputed political, moral, and religious topics. Public statements in the name of the University should be avoided, except where appropriate to address an issue that bears materially and directly on the University's core mission. The role of the University is to provide an impartial platform for scholarly debate; it is not to pronounce judgment.

A position of institutional neutrality is not intended to limit the speech of the university's community acting or speaking as individuals in their own names and not in the name of the university. Rather, institutional neutrality allows the university to be a true marketplace of ideas in which students, faculty, and staff have the broadest possible latitude to speak, write, listen, challenge, learn, and discuss any issue. However, when acting in a personal capacity as a citizen, an employee of the university speaks publicly or writes for publication, the employee shall take care to ensure that the employee's statements are not reasonably interpreted as being made on behalf of the University.
